This form and the Change of Address form are available, at the City of Waterbury Town Clerk's office and on the web at www.waterburyct.org - Government Services - Town Clerk - Landlord Registration Form. Failure to complete and file this form may result in the imposition of penalties including a fine of up to \$1,000.

After October 1, 2012, the Fee For Registration is \$25 per property, with a maximum of \$50 per Non-resident owner. The fee for change of address per property is \$10, with a maximum of \$20 per non-resident owner.
