

## BOARD OF FIRE COMMISSIONERS

**§31.060:** In accordance with the provisions of §6C-6 of the Charter of the City of Waterbury, there shall be a Board of Fire Commissioners which shall consist of seven (7) members, no more than four (4) of whom shall be members of the same political party. One (1) member shall be a member of the Board of Aldermen for a term corresponding to said member's immediate term as an Alderman. Successors shall be appointed for a term of four (4) years.

The Commission shall meet on the **Fourth Thursday** of the month at 5:30 p.m.
