"Household Hazardous Waste" refers to items from your garden, workshop, toolshed, garage and even kitchen that are poisonous or otherwise dangerous e.g. bug spray, brake fluid, drain cleaner etc.

- PCBs, DDT
- Dioxin/dioxin forming materials (pentachlorophenol), pesticides containing 245 T, Silvex
